Update on the 2023 TICA Annual, Sep 2-3, 2023, Tacoma,

This is a 14 ring continuous format show allowing up to 500 entries. On September 2, 2023 we will also host the international awards banquet. Updates on moving from Isolated Status to 'regular' status as of May 1, 2023 — there are a number of related rules and procedures that will revert back to pre-COVID status as of May 1, 2023. They are;

Standing Rules related to Show Rules:

202.2.2 For the 2020/2021, 2021/2022, and 2022/2023 show seasons only, all Regional Directors have given advance permission for clubs to sponsor Alternative Format shows. **As of May 1, 2023, clubs will need the Regional Director's permission to sponsor alternative format shows if NOT in an isolated area. Only the state of Alaska is considered an 'isolated area' in the Northwest Region.**

207.1.1 Requirements for Titles. All points earned are cumulative. After earning the points required for one title, any remaining points apply to the next title. For purposes of scoring for individual cat titles, cats shown in the 2019/2020 show season will have titles recomputed under Standing Rule 207.1.1.2—Isolated Areas and be notified that those titles may be claimed. Those cats, along with additional cats shown in the 2020/2021, 2021/2022 and 2022/2023 show seasons will continue to earn titles computed under Standing Rule 207.1.1.2—Isolated areas through April 30, 2023. **At the conclusion of the 2022/2023 show season and prior to reverting to non-isolated scoring, the Executive office will notify owners of any unclaimed titles earned under these rules and allow a reasonable period of time to claim titles.**

209.3.4 For the show season 2020/2021, 2021/2022 and 2022/2023, the Board has determined that an 'emergency' situation exists and that clubs holding shows during these three seasons, shall be additionally authorized to contract judges under 'isolated area' terms. **As of May 1, 2023, clubs can no longer contract judges in under 'isolated area' terms for non-isolated areas.**

Standing Rules related to Scoring:

901.4.3.2 In order for a cat/kitten to be eligible for a regional award, it must be shown at least once in that region during the show year for which the regional award was won. An exception will be made in the case of kittens and household pet kittens in that a show as an adult will fulfill the requirement that they be shown one time in the region. ~~This rule is suspended for the 2021/2022, 2021/2022 and 2022/2023 show seasons.~~ **As of May 1, 2023, a cat/kitten must be shown at least once in that region during the show year for which the regional award was won.**

901.4.3.4 Regional Awards. Regional Awards will be presented to the 25 cats, kittens, alters, household pets, household pet kittens and 25 longhair cats and 25 shorthair cats having the highest aggregate points of all cats, kittens, alters, household pets and household pet kittens, as applicable in the region. For the 2021/2022 show season the aggregate points must be at least 500 (300 for International area). **Beginning with show season 2022/2023 the aggregate points must be at least 1,000 (600 for International area).** All awards earned during the show year will be listed accordingly for every region or recognized area and internationally.

Standing Rules related to Judging Program:

401.1.6.1 The number of Guest Judges allowed to judge shows in isolated areas shall be considered on a case-by-case basis. Exceptions to 410.1.5 and 410.1.6 shall be considered on a case-by-case basis. ~~For the show seasons 2021/2022 and 2022/2023 only, this provision shall also apply for any should hold in any Region.~~ **As of May 1, 2023, this provision will only apply to shows in isolated areas. (For the Northwest Region, this will only apply to any shows put on in the state of Alaska.**

Do you want a show in your local area? — Now that we are over the COVID pandemic and shows are starting back up again, have you ever been interested in having a TICA cat show in your local area?

There are many people in our region that would be more than willing to help put together a club in your local area in order for you to host a cat show. And, there are some incentives right now you can take advantage of — TICA does not charge part of the show license fee to new clubs if they put on a show within 1 year of chartering the club; the region has a fund in our bank account that can loan a club money to set up their shows (but yes, it needs to be repaid); and the Regional Director is willing to put you in touch with others in your area to help organize a club.

Recap of Winter Board Meeting — The Winter Board meeting was held via Zoom on January 16-18, 2023 via Zoom.

The Board reviewed a report by Jeff Shi, Asia West RD regarding the proposal to legalize TICA to conduct business in China. The majority of the Board did indicate their support of starting up shows again in China. Board members were instructed to provide their questions in written form so they can be addressed prior to making any final decisions about how TICA will be in China.

Employee health benefits were discussed. The COO and Bus Mgr. will review current staff salaries and whether additional employee benefits will be offered to employees. Any changes will be budgeted for the next fiscal year starting July 1.

Financial Report – Vickie Fisher gave an overview of TICA's current financial position. Some highlights ...

We expect a slight profit at the end of the fiscal year (June 30 2023).

Memberships are down slightly (from last year), but expect renewals towards the end of the fiscal year.

Litter registration revenue is way up!

Certified pedigrees are up!

Cost of TFMS maintenance is a little more than expected due to higher numbers of non-members versus members using services.

Board approved some minor budget adjustments.

Board accepted the financial audit report – our accounting has been deemed 'clear'.

COO (Chief Operating Officer) Report – Danny Nevarez

Customer Service – TICA is delivering service faster than ever before. We are seeing an 80% increase in new clients. Our backlog has gone from 8,000 to 100 cases. Service orders are being handled within 1 day.

TOES integration project – Phase 1 is complete. Expect to hear an update within the next few months.

Breeder Listings – self-service breeder listings for TICA members should be launched within the next 90 days (or so). More information to follow.

Immediate self-service items are over 50K. Catteries—4,967, litter registrations—39,958, and pedigrees—8,390.

Growth – after 3 banner years TICA is continuing to recognize growth. We've had an increase of 80% in new clients over the last year.

Website development — We now have a new webmaster. Improvements since Sept 2022 include: Judges' pages updated. International winners on front page have been updated. Standings are updated on the website the day they are received from the EO. The upcoming events page has been updated with outdated events removed. Our people and committee pages have been updated. All current breeder listings have been updated with the same information. The 2022 membership ballot page is updated with election results.

Board initiatives – Projects in progress and in the pipeline for work are: TOES integration; Junior Exhibitor program improvements; Club management portal; Regional stats for RD's; Strategic planning.

The discussion of proposed changes to the Burmilla Group Standard has been postponed to the Spring Board meeting.

Isolated status of all shows will cease as of April 30, 2023. Put another way, our 'normal' rules will apply with the new show season beginning May 1, 2023.

The TICA Executive Office will be notifying all people that have titles earned through April 30, 2023 in isolated status. If a person does not apply for those titles earned during the isolated status within the grace period, title requirements will revert to those requirements earned under 'normal' operations.

Proposed changes to rules:

Amend Judging Program 41.5.7 (Meetings) – passed

Amend Judging Program Article Nine (Acceptance of Judges from Other Cat Associations) – passed

Amend Judging Program Article Ten (Guest Judges) – passed as amended

Amend Judging Program Article Eleven (Reinstatement) – passed

Amend Judging Program Article Twelve (Leave of Absence and Resignation) – passed (I voted 'no')

Amend Standing Rule 106.4.1 (Advisory Standing Committees) – passed

Add Standing Rule 106.4.1.6 (Standards Committee) – passed

Amend Standing Rule 1012.2 (Additional Regions) – passed

Add Standing Rule 1024.4 (Voting Rights) – withdrawn – an Ad Hoc Committee will be formed to review TICA's governance structure and policies.

The proposed changes to the JE Program were passed. The JE Committee has been instructed to incorporate a general clause to comply with local laws (i.e., in parts of the world, cats cannot be owned by children), include definitions of: Junior Exhibitor; JE Liaisons, and must obtain signed parental approval for children to participate in a JE judging ring.

Update on 2023 TICA Annual – Tacoma, WA – Andre gave an update. 105 room nights have been reserved so far at the Marriott. The banquet meal order form will be posted on the website by the end of February. Admission tickets are now available online. There will be a cat celebrity at the show (like Lil' Bub who was at the 2017 regional show).

The Legislative Committee is looking for additional members. If interested in working on this committee, please contact Susan Adler Johnson at nycsa@aol.com.

The Marketing Report – Roeann Fulkerson

The Club Sponsorship Program is still going strong. There has been almost \$23K funded to clubs for 2023 shows with almost as many international club sponsorships funded as there are North American shows. The program is currently under review and is being updated, which will soon reflect a more simplified application form and updated requirements for funding.

There is also funding for Junior Exhibitor judging at our shows as well. If your club is having JE judging, be sure to note that on your Application form (found on the TICA website <https://www.tica.org/downloads/file/78-2020-tica-sponsorship-form-pdf>).

TICA will be participating in several grooming expos in 2023. TICA must staff each event with 2-3 live cats and humans to interact with the public, allow the groomers to pet the cats, not just show up and be on display. 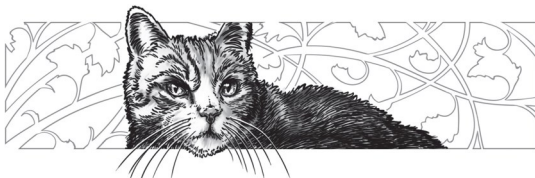

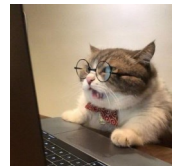

Breeder Assistance: Did you know the Region can help breeders with financial problems? This committee assists breeders who reside in the TICA NW Region, and who find themselves needing temporary (or more permanent) assistance.

This Committee helps with advice, food, physical assistance, and placement of cats, but only if requested. Assistance provided through this committee is 100% confidential.

Help and support is provided (if requested) for reasons such as:

- Illness, temporary or permanent disability
- Death, without provision for the animals
- Temporary loss of home or housing
- Loss of employment
- Unforeseen change in personal family situation
- Temporary financial hardship
- Number of cats beyond care capacity
- New legislation in the area which affects the number of cats allowed in a household
- Acts of nature
- Need for temporary food, litter and/or vet card (if funding can be secured).

If you find yourself in need of help, contact the Regional Director. You will be put in contact with someone in your local area that can help you!

IMPORTANT NOTES:

- When making any payment, be sure to identify what the payment is for and who it is from.
- Sorry, the region cannot accept E-transfer payments from Canada because the Region's bank account is in the United States. E-transfers only work from one Canadian bank account to another.

Did you remember to pay your entry fees for a show? Ever have that moment when you weren't sure if you paid your entry fees for a show and can't find your confirmation? If the show uses TOES for entries, there is no need to contact the entry clerk. Just log in to TOES and click on the show in the show calendar. Scroll to the bottom of the show details. You will see the cats you've entered in the show. Below that you will see the space you requested along with the total amount owed, paid and due!

Important notes:

- 1) You won't see any information on your cats, space, etc. if you aren't logged in!
- 2) If you only have placeholders the financial data will not show. You need to have at least one cat's information entered for the financial summary to display.

REMINDERS:

- ♦ **Voting in TICA elections and proposed rule changes** — In order for you to vote in each Fall's balloting for elections of TICA Officers, Regional Directors, Breed Committees, etc., and **to vote on proposed rule changes, you must be a member as of April 1 AND renew your TICA membership during May 1 through June 30 to be eligible to vote in the upcoming Fall ballot.** Put another way, if you join TICA on May 1 you are not eligible to vote in the Fall election because you were not a member as of April 1.
- ♦ **Dr. Elsey sponsorships** — Don't forget to request corporate sponsorship from Dr. Elsey's for your show(s). The sponsorship form is available at tica.org. When you get to the main page, click on the search bar (upper left hand corner) and type in "Sponsorship Form". There you will find all the infor-



mation you need to submit a request for sponsorship. Also remember, if you receive a TICA Dr Elsey sponsorship for your show, include the Dr Elsey logo on your website, show flyer, exhibitor catalog, marked catalog, and all promotional materials and submit a report after the show's completion. Thank you for your support!

- ♦ **Change of Address** — Remember to notify the TICA Executive Office, TICA Trend Editor AND the Regional Director of changes of address, phone, and/or email.
- ♦ **Lifetime Achievement Award**—If your cat has achieved a combination of 3 IW's/RW's, with at least one IW, your cat is eligible for a Lifetime Achievement Award! This award is NOT automatic. You need to apply for it: <https://tica.org/resources/our-forms/file/54-lifetime-achievement-award>. If your cat is achieving its third IW/RW win in the current show season, and you want your LA title to be on the awards, **your claim form must be submitted to the EO by May 7 of that year.** Note: If you apply after May 7, the LA title will not show up on your awards as of the past show season. You can apply for the title at any time - even for cats that were shown years ago - and the LA will be recognized in any future show season.
- ♦ **Outstanding Sire/Outstanding Dam** - Female cats who have given birth to 5 kittens who have achieved the title of GRAND CHAMPION or GRAND CHAMPION ALTER or higher can apply for the title Outstanding Dam. Male cats who have sired 10 kittens who have achieved the title of GRAND CHAMPION or GRAND CHAMPION ALTER or higher can apply for the title Outstanding Sire. Do you have cats that qualify? The titles aren't automatic so you will need to use the appropriate form to claim your cat's titles:

- ♦ **Marked Catalogs** — Attention Clubs: Please send the Clerking Administrator, Caroline Fralia, a marked catalog when distributing them to the EO, RD, etc. Her email is: mcfralia62@gmail.com.
